### Role of wali

A wali is the bride's lawful guardian who is responsible for the bride's life prior to marriage. It is his duty to ensure that the proposed groom is a reliable and trustworthy person who will continue to carry on his role and responsibility towards the bride after marriage.

### Who is eligible

Listed in the order of hierarchy, a wali can be the bride's birth father, her paternal grandfather, brother, paternal uncle or any male relative from her paternal side, and must be:

6 Attend appointment with ROMM

7 Solemnisation

- A Muslim of sane mind and have attained the age of puberty
- Conceived after his parents' marriage, which is lawful in accordance with Syariah Law
- Not an adopted child

In the event that your wali is unavailable



### Wali's roles and responsibilities

- Give consent to your marriage
- Provide his personal information for your marriage application
- Accompany you to the ROMM appointment with his original identification for verification of documents and statutory declaration
- Be present with original identification on your solemnisation day for verification
- Conduct the solemnisation himself or authorise the Kadi or Naib Kadi to solemnise the marriage
- Sign your marriage certificate during your solemnisation

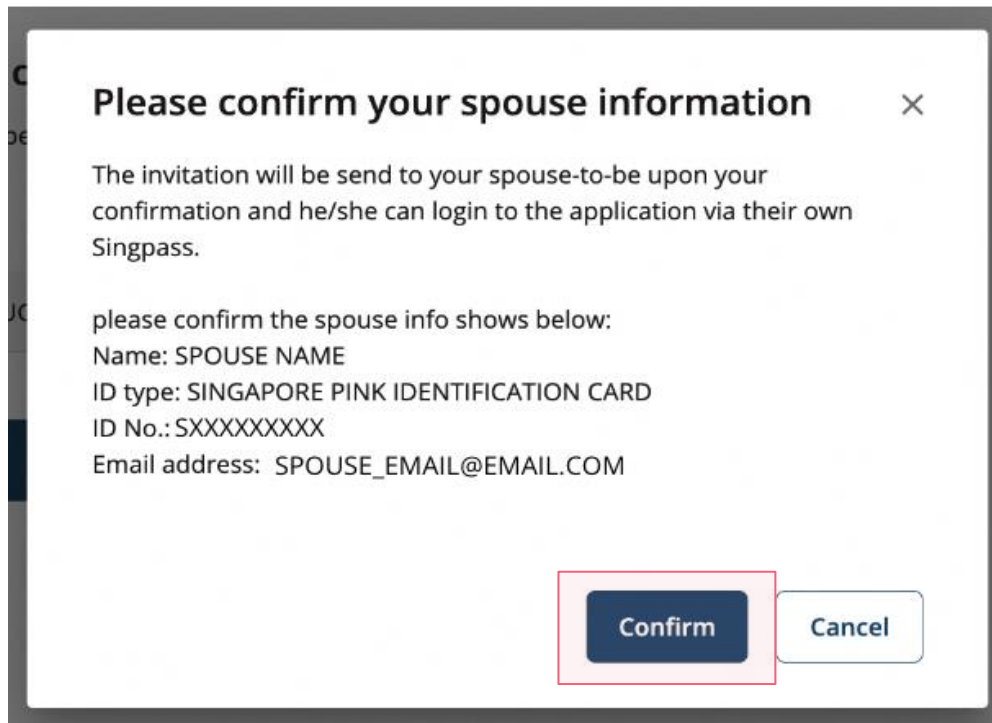
